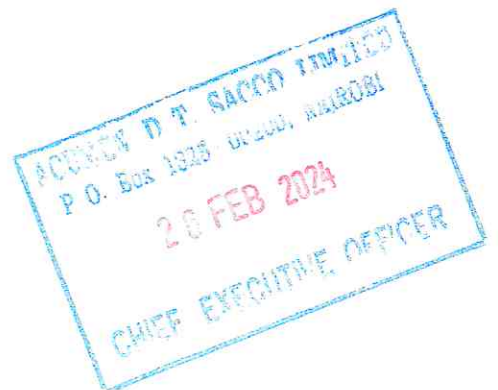
Background

Aimed at facilitating internal and multi-stakeholder meetings and consultation processes, the scope of work of the architect will include but not be limited to:-

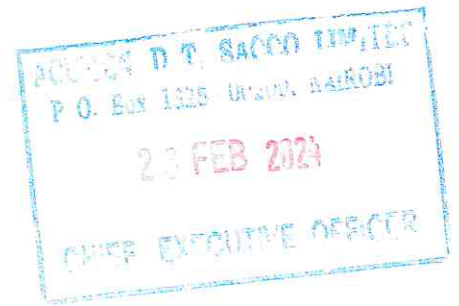
- a) Undertake to understand the needs of the Society in terms office layout for the current capacity and projected 10 year office needs.
- b) Undertake a stakeholder mapping and analysis, and hold consultations with key stakeholders;
- c) Through a consultative process develop a design of the new office premises taking into consideration of the need to provide sufficient clean aeration, sufficient natural light, above standard plumbing, sewerage & electrical works, security of the building, suitability of the office layout in relation to the business of the Society, fire & emergency need and sustainable energy needs for the building.
- d) Finalise the office design complete with accurate measurements and deliver to Acumen Sacco Society Ltd.

Deliverables

- a) Most competitive office design that achieves: optimum use of space, office design that is customer friendly, proper ventilation, sufficient natural lighting, working plumbing/sewerage works/ electrical works, adequate security, provides for fire & emergency evacuation & sustainable energy needs.
